Warriors and Caregivers United (WACU) puts on family and warrior events to help PTSD military Veterans not chose suicide, and help families of these Veterans on their journey together after he/she returns from military deployment. Our work also potentially saves marriages. Our focus is on warriors receiving mental health treatment, or have received such treatment after their military service. Our Mission is "Embrace Warriors and Caregivers in a non-judgmental, safe, and unassuming environment. Develop acceptance of existing resources and systems to educate and promote utilization. The following are events we organize for those warriors and caregivers who would like to attend, with their family if they have children. We focus as much on the Caregivers as we do the Veterans. Both groups share resources and discussion sessions and realize they are not alone in their PTSD experience with an affected Veteran. Our WACU family of attendees reside over most of lower Michigan, so events are all over that area and may be duplicated in one area and then another.
